## Job Description

## ROLE AND RESPONSIBILITIES

- Coordinate plans with the Council NYLT Coordinator.
- Coordinate and inform the MSR Ranch Director of all issues while on site. Assist with investigations and response. Report issues with participants and staff immediately.
- Be familiar with and direct the camp emergency procedures as directed by the MSR Ranch Director as needed.
- Recruit quality adult and youth staff members. Ensure required paperwork is completed by all staff prior to their arrival to camp.
- Conduct staff training that meets BSA NYLT, BSA Camp Standards and State of Colorado requirements prior to the NYLT session.
- Help the staff develop a vision for the courses, and the goals and plans to fulfill the vision.
- Attend a region/area course directors conference within 18 months prior to the start of the session.
- Be well-versed on all core content sessions in order to act as a resource and role model to participants.
- Conduct the course as outlined in the BSA NYLT syllabus and manual.
- Serve as mentor and coach to the youth leader and other NYLT youth staff.
- Work closely with Assistant Scoutmasters and other adult staff to ensure their effectiveness in completing staff assignments.
- Model core learning and leadership messages of the NYLT syllabus.
- Other duties as assigned.
